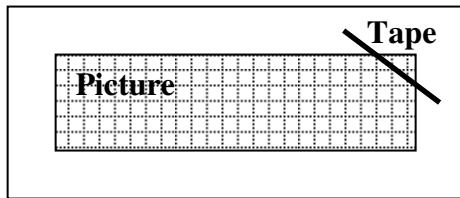

Visual Arts Exhibit Specifications

These directions must be followed!

1. Due to limited space, submit only one (1) art work per participant.
2. Choose only the best work. Do not send multiples of the same project.
3. Flatwork not to exceed 18" x 24".
4. Lightweight mats only. NO FRAMES OR GLASS will be accepted.
5. Art must be held in the mat with cellophane tape or masking tape.
6. Art work without a label cannot be accepted.
7. Inside of mat should overlap the picture at least 1/4 inch.
8. Tape must be placed at right angles on mat. DO NOT put tape parallel with mat, as it is inclined to peel off.

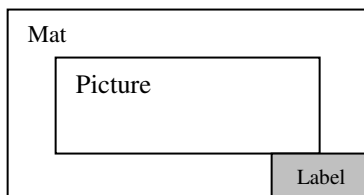

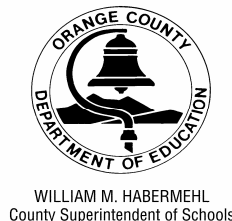
